The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Department of Public Safety, Division of Adult Corrections and Juvenile Justice, Juvenile Community Programs section in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state fiscal year 2018-2019 beginning on, or after, July 1, 2018. The use of these funds in this county requires a local match in the amount specified above.

**The JCPC will consider proposals for the following needed programs:**

*Restitution/Community Service	*Parent/Family Skill Building (Strengthening Families or other EBPs)	*Cognitive Behavioral Groups
*Psychological Assessments & Sex Offender Specific Evaluations	* Social Skill Building programs for chronic and serious offenders	*Teen Court
*Temporary Shelter Care	*Tutoring/Academic Enhancement Programs	*Afterschool Programs ( EBP Life Skills)
*Vocational Development programs		* Experiential Skills Programs

**Proposed program services should target the following risk factors for delinquency or repeat delinquency:**

Adjudicated delinquent, undisciplined or youth at high risk of delinquency who: have prior referrals to juvenile court, have some substance use or abuse, have moderate to serious school behavior problems and sometimes or regularly associate with delinquent peers or associate with or are gang members.

**Programs should address the following concerns as reported in the Needs Assessments for adjudicated youth:**

Peer Domain: Lack pro-social peers, associate with delinquent peers or have gang association or membership.

Individual Domain: Have alcohol or drug use or abuse, have a history of abuse or neglect, have a history of victimization or are in need of further mental health assessments and/or treatment.

Family Domain: Have families with domestic discord or violence, parents with marginal or inadequate parenting skills or have family members with a criminal history or gang involvement.

School Domain: Have moderate or serious school behavior issues that include in school suspensions, short term or long term suspensions, truancy or unexcused absences.

**Applicants are being sought that are able to address items below:**

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services detect gang participation and divert individual, if applicable.

**Local public agencies, 501(c)(3) non-profit corporations and local housing authorities are invited to submit applications to provide services addressing the above elements.**
