Public Notice from Sheriff Greg Seabolt

Permits by Mail:

The Randolph County Sheriff's Office will begin accepting and issuing pistol purchase permits and Concealed Carry permits (to include change of address and name changes) by mail. Until further notice, all requests for a pistol purchase permit or a new or renewal of a concealed carry permit will need to be done by mail. All new and renewal applicants are asked to visit <https://randolphso.permitium.com> to access and print out an application. If potential applicants do not have computer or internet access, they are encouraged to contact the Sheriff's Office to have an application mailed to them. The following documentation is required:

Pistol Purchase Permit items needed (Permits will be approved or denied within 14 days)

1. A completed pistol purchase permit application (printed from Permitium website)
2. A photo copy of your current valid NC driver's license or ID card reflecting current residential address
3. A copy of one of the following: current utility bill, vehicle registration, or piece of mail containing your name and residential address
4. A notarized mental health release: you are required to get this paper notarized prior to mailing (printed from Permitium website)
5. Recent name change due to marriage or divorce: will need to provide a copy of your marriage license or divorce decree

Concealed Handgun Permit NEW or RENEWAL items needed (Permits will be approved or denied within 90 days)

1. A completed and notarized concealed handgun permit application (printed from Permitium website)
2. A photo copy of your current NC driver's license or ID card reflecting the applicant's current residential address
3. A photo copy of your current concealed handgun permit, if a renewal
4. A notarized mental health release: you are required to get this paper notarized prior to mailing (printed from Permitium website)

5. Signed copy of the Do's and Don'ts of carrying a concealed handgun permit (printed from Permitium website)
6. Recent name change due to marriage or divorce: need to provide a copy of your marriage license or divorce decree

Concealed Handgun Permit Address Change/Name Change items needed

1. A completed and notarized address change form (printed from Permitium website)
2. A photo copy of your driver's license with your new address on it
3. A photo copy of your concealed handgun permit
4. Please write your current phone number on address change form in case we have any questions
5. Copy of your marriage license or divorce decree for any name change

**NOTE: For any of the above services, the applicant's address must be current and match on all forms and documents mailed to the Sheriff's Office. If there is any discrepancy, the permit will be delayed.**

Please consider that permit applications have increased dramatically since the onset of the COVID-19 pandemic. The Sheriff's Office is using all available manpower to process applications and therefore will not take any calls inquiring about the status of an application. Applicants who use Permitium will receive notification that permits have been approved prior to mailing. Any approved pistol purchase permit, concealed handgun permit, or address/name change will be mailed through the United States Postal Service. Pick up is not available at this time.
