I. Call to Order

The Randolph County Board of Health held a called meeting on Thursday, January 3, 2019, in Randolph County Health Department conference room. Dr. Lee, Board Chair, called the meeting to order at 6:02 p.m.

II. Public Comment Period

Dr. Lee opened the public comment period. Hearing no requests, the public comment period was closed.

III. Rule Repeal – *A Rule to Prohibit Tobacco on Local Government Grounds and in Local Government Buildings and Vehicles*

Susan Hayes, Randolph County Health Director, asked board members to consider repealing the Board of Health rule adopted October 23, 2018 entitled *A Rule to Prohibit Tobacco on Local Government Grounds and in Local Government Buildings and Vehicles*. Ms. Hayes stated that when the rule was presented on December 3, 2018 to the Randolph County Board of Commissioners there were some commissioners that felt “*tobacco use*” would better clarify

violations to the rule. Randolph County Board of Commissioners voted to table the rule for further review on January 7, 2019.

Dr. Brown made a motion to "*Repeal A Rule to Prohibit Tobacco on Local Government Grounds and in Local Government Buildings and Vehicles.*" (See repealed rule following the minutes.) Ms. Haywood seconded the motion and the motion carried.

IV. Presentation of Draft Proposal - *A Rule to Prohibit the Use of Tobacco and Tobacco Products on Local Government Grounds and in Local Government Buildings and Vehicles*

Susan Hayes, Health Director, presented a draft proposal of *A Rule to Prohibit the Use of Tobacco and Tobacco Products on Local Government Grounds and in Local Government Buildings and Vehicles (draft rule proposal following the minutes)*. Ms. Hayes noted revisions from the original rule. Revisions included clarification that the *use of* tobacco and tobacco products is prohibited, clarification that local government grounds does not include public streets and the sidewalks abutting said streets and a change to the effective date from March 1, 2019 to May 1, 2019.

Board members reviewed and discussed the proposed draft rule. After some discussion, board members agreed to revise the effective date to include May 1, 2019 *or 60 days after the date of adoption, whichever is later, of this Rule by Ordinance by the Randolph County Board of Commissioners pursuant to NCGS 153A-121(a)*. Dr. Hill made a motion to "*Approve the suggested change to the effective date on the proposed draft rule to include the addition of 60 days after the date of adoption, whichever is later.*" Dr. Brown seconded the motion and the motion carried.

Board members commented in support of the proposed draft rule. After further discussion, Dr. Walker made a motion to "*Approve A Rule to Prohibit the Use of Tobacco and Tobacco Products on Local Government Grounds and in Local Government Buildings and Vehicles.*" Ms. Haywood and Ms. Richardson seconded the motion and the motion carried unanimously.
