The Juvenile Crime Prevention Council (JCPC) has studied the risk factors and needs of Juvenile Court involved youth in this county and hereby publishes this Request for Proposals. The JCPC anticipates funds from the NC Dept. of Public Safety in the amount stated above to fund the program types specified below. Such programs will serve delinquent and at-risk youth for the state **fiscal year 2014-2015** beginning on, or after, **July 1, 2014**. The use of these funds in this county **requires a local match** in the amount specified above.

**The JCPC will consider proposals for the following needed programs:**

Restitution/Community Service	Counseling ( ART, FFT or other Evidence Based Models )	Parent/Family Skill Building
Psychological Assessments	Afterschool Program offering EBM Life Skills	(Strengthening Families or other EBMs)
Substance Abuse Assmts & Treatment	Teen Court	Temporary Shelter Care
Structured Day Programs		Cognitive Behavioral Groups

**Proposed program services should target the following risk factors for delinquency or repeat delinquency:**

Adjudicated delinquent, undisciplined or youth at high risk of delinquency who: have prior referrals to juvenile court, have some substance use or abuse, have moderate to serious school behavior problems, sometimes or regularly associate with delinquent peers or associate with or are gang members.

**Programs should address the following concerns as reported in the Needs Assessments for adjudicated youth:**

Peer Domain: Lack pro-social peers, associate with delinquent peers, or what have gang association or membership.

Individual Domain: Have alcohol or drug abuse, have a history of abuse or neglect, have a history of victimization or are in need of further mental health assessments.

Family Domain: Have families with domestic discord or violence, parents with marginal/inadequate parenting skills or have family members with a criminal or gang history.

School Domain: Have moderate or serious school behavior problems (truancy, short or long term suspensions, dropped out or are expelled.)

**Applicants are being sought that are able to address items below:**

1. Program services compatible with research that are shown to be effective with juvenile offenders.
2. Program services are outcome-based.
3. The program has an evaluation component.
4. Program services that decrease delinquent behavior, gang participation or divert individuals from gang participation.

**Local public agencies, 501(c)(3) non-profit corporations and local housing authorities are invited to submit applications to provide services addressing the above elements.**
